6.1 Financial overview: Ben Newton

Ben gave an overview of the figures in the Annual Report as well as an update to August 2023. TCF started 2022/23 with major worries after the reduction in trade post-lockdown and an overall loss in 2021/22. This has been turned around, from August 2022. Overheads were reduced, and customer numbers were increased thanks to a low-cost 'Stand With Us' campaign. A further major change has been the increase in grants and other income. The financial year ended with a surplus and we currently have cash in the bank.

Questions and discussion followed.

6.2 Farming: John Miller

John has been In post for about a year, and his role brought a new arrangement, combining oversight of both food and farming. It has been a very challenging year both weather-wise and trading-wise, especially for organic farms. Production costs have increased and demand has reduced nationwide. TCF took the decision, when our previous head grower left, to instead have a team of three growers who work collaboratively together and each take a lead on different aspects of the Farm. This has required new ways of working, and is bringing benefits

6.3 Communities, partnerships and wildlife: Daisy Sutcliffe

Grants income has enabled us to continue all five strands of the communities programme:

- Volunteering
- Growing wellbeing (with Ecowild)
- Schools (with Earthwise)
- Community outreach partnerships
- Events

Daisy gave an overview of the Communities programme, mentioned the partnership work with Chew Valley School, and the important work of the Wildlife group. She paid tribute to all her colleagues, and finished by reading aloud Adam Horowitz's poem *The Soil Never Sleeps*.
